- Nonterminal criminal conduct against the body, including robbery, kidnapping, false imprisonment, assault, and hate crimes
- Sexual assault, rape, necrophilia, incest, and child molestation
- Property offenses, such as larceny/theft, bribery, forgery, and embezzlement
- Crimes against the home, including burglary, trespass, arson, and vandalism

The book also examines controversial public morality issues such as prostitution, drug legalization, obscenity, and pornography. The final two chapters discuss inchoate offenses, where the criminal act has not been completed, and various criminal defenses such as legal insanity, entrapment, coercion, self-defense, and mistake of fact or law.

Important keywords introduce each chapter, and discussion questions and suggested readings appear at the end of each chapter, prompting lively debate and further inquiry into a fascinating subject area that continues to evolve.
